<u>Walter Augustine "Walt" Swanstrom</u>, 95, March 7, 2007 died at the Benedictine Health Center Safe Harbor Duluth. Walter was a veteran of the Minnesota National Guard and the U.S. Navy during World War II. **He was a boy scout leader for 50 years**. He was part owner of General Appliance store in Duluth until 1962. He then went to work for the U.S. Navy in Panama Canal Zone as Mechanical Engineer. Followed by work with Air Force in Washington state. He retired in 1976 returned to the Duluth area. Father, grandfather, great grandfather, and loving husband was preceded in death by his wife, Anne of 56 years; first son, Walter John; brothers Cody, Pete and Dick; and sister, Jane. He is survived by his daughter, Susie Clark (Archie) of Pike Lake,

Minn.; sons, Skip of County Claire, Mich., Tom (Mary Kay) of Duluth, Bill (Sue) of Apple Valley, Minn., and Pat (Janice) of Thousand Oaks, Calif.; and nine grandchildren and seven great grandchildren.

Research

Unfortunately, there are no easily accessible online newspaper sources for Duluth, MN. However, an article on Wikipedia indicates that Duluth, MN, was part of the North Star Council until it merged with the Gitchee Gumee Council in 1959 to form the Lake Superior Council. The Lake Superior Council later merged with the Headwaters Council in 1997 to create the <u>Voyageurs Area Council</u>. This would place the date that the trophy was given to Mr. Swanstrom at 1959 or earlier. This aligns with this particular style of trophy.

It is possible that this trophy was presented to <u>Walter A. Swanstrom Sr.</u>, though there is no evidence that Walter Sr. volunteered with the BSA. However, Walter Sr. passed away in 1964 at the age of 82. Walter Sr. was politically involved, which would suggest possible involvement with the BSA. Of interest is that Walter Sr. advocated for the move to an 8-hour work day.
